GENERAL SEAT (3)

1. Will be a member of the committee but with no designated role or representation on other Regional or National bodies or SOGs.

NATIONAL DISABLED MEMBERS COMMITTEE REPRESENTATIVES (x 2)

2 year term.

- 1. Attend and participate at National Disabled Members Committee meetings/working parties/seminars and training events (this will involve stays away from home).
- 2. Represent the views of Eastern Region disabled members/present motions from RDMC.
- 3. Attend (or provide a written report to) Regional Disabled Members Committee and provide feedback and information and updates
- 4. Should be a representative on the Regional Council.

NATIONAL DISABLED MEMBERS COMMITTEE REPRESENTATIVES' SUBS (x

2) 2 year term

- 1. Attend and participate at National Disabled Members Committee meetings/working parties/seminars and training events (this will involve stays away from home) when Committee Reps are unable to.
- 2. Represent the views of Eastern Region disabled members/present motions from RDMC.
- 3. Attend (or provide a written report to) Regional Disabled Members Committee and provide feedback and information and updates.

4. Should be a representative on the Regional Council

REGIONAL EXECUTIVE REPRESENTATIVE (x 1)

- 1. Represent the RDMC on the Regional Executive.
- 2. Attend (or provide a written report to) Regional Disabled Members Committee meetings.
- 3. Facilitate exchange of information between the two committees
- 4. Should be a representative on the Regional Council

REGIONAL COUNCIL REPRESENTATIVES (x 2)

- 1. Attend (or provide a written report) to Regional Disabled Members Committee meetings.
- 2. Attend, represent and participate in Regional Council meetings on behalf of the Regional Disabled Members Committee
- 3. Facilitate exchange of information between regional council and the RDMC

TUC LESE Committee (x 2)

- 1. Attend and participate in TUC LESE Meetings and events
- 2. Facilitate exchange of information between TUC LESE and the RDMC
- 3. Meetings are usually held at the TUC office in London in the afternoon

LABOUR LINK REPRESENTATIVE (x 1)

- 1. Represent the RDMC on the Regional Labour Link Committee.
- 2. Attend (or provide a written report to) Regional Disabled Members Committee meetings.

(In the event of the Disabled Members Conference rep being unable to attend)

- 1. Represent the Eastern Region Disabled Members at the National Disabled Members Conference
- 2. Chair the Eastern Region Disabled Members regional welcome meeting
- 3. Move and speak to the motions and amendments submitted by Eastern Region Disabled Members Committee,
